## **Brief Description of Job:**

- Handles all telephone traffic both into and out of the department.
- Schedule all clinics and clinic procedures.

- Obtains vital signs on patients as needed.
- Coordinates the nursing care of the clinic patient. Including pre-procedure assessment and implementation of plan of care, assisting physician with evaluation, treatment or procedures, assessment of patient post-procedure, education of patient and family and coordination of follow-up care.
- Tracks all patient visits and initiates billing process as needed.
- Maintains Medical Records as needed.
- Operates various office machines.
- Maintains patient care supplies and equipment within the unit.
- Administers Nailcare safely, following established protocols and physician referral. Review referrals for appropriate diagnoses.
- Performs documentation within the department and in the patient record accurately, concisely and in a timely manner.

- Supervises patient care as delivered by LPN or nursing assistant.
